Proposed Action or Project Description:

The Office of Legacy Management retains responsibilities for monitoring groundwater and maintaining site features at the L-Bar site, a Title II Site under the Uranium Mill Tailings Radiation Control Act. Routine monitoring and maintenance actions include sampling groundwater wells every 3 years and well development every 6 years, which could result in the purging of 500 to 1,000 gallons of water that would be absorbed by the soil. Other typical site activities may include minor road grading on site dirt roads, fence repair, spot use of pesticides to control noxious weeds (tamarisk), surveying, small erosion repair actions following extreme weather events, and site tours and inspections. Activities proposed for 2012 include the installation of a precipitation gauge with telemetry and replacing 4-5 site monuments.

None of these actions would affect protected species or cultural resources. The L-Bar site was subject to uranium mining and milling activities prior to remediation.

There are no extraordinary circumstances related to the proposal that may affect the significance of the environmental effects of the proposal.

The proposal has not been segmented to meet the definition of a categorical exclusion.
