### Description:

A9 Information

Information gathering (including, but not limited to, literature surveys, inventories, site visits, and gathering, analysis, audits), data analysis (including, but not limited to, computer modeling), document preparation and dissemination (including, but not limited to, conceptual design, feasibility studies, and analytical energy supply and demand studies), and information dissemination (including, but not limited to, document publication and distribution, and classroom training and informational programs), but not including site characterization or environmental monitoring. A11 Technical advice and assistance to organizations

Technical advice and planning assistance to international, national, state, and local organizations.

### Rational for determination:

The U.S. Department of Energy (DOE) provided \$1,014,000 of federal funding to the State of Florida under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. Florida will match the federal funding with \$202,800 in State funds, for a total of \$1,216,800.

The Florida Department of Agriculture and Consumer Services (FDACS) proposes to fund the following Market Titles:

### Administration:

Under this Market Title, funding would be used to perform general grant management and oversight, and would provide and present information on sustainable renewable energy projects and initiatives to outside entities, including legislators, state agencies, and the public. Additionally, funding would be used to support the continuing operation of the SEP activities performed by the FDACS personnel.

## Biofuels Development:

Under this Market Title, funding would support the review of biofuels projects submitted for State incentives. FDACS would assist in planning and hosting the Florida Energy Summit in the fall of 2012. SEP funds would only be utilized to review the projects submitted under the State Funded incentives program and would not be used for incentives or installation.

Under this Market Title, funding would be used to attend building commission meetings and update State energy efficiency standards for State purchased and managed appliances.

## Emergency Operations Center Support and Planning:

Under this Market Title, funding would provide staffing support in declared emergencies for liquid fuel-related issues.

## State Energy Plan/Policy:

Under this Market Title, funding would be used to develop and implement energy policy and legislation. FDACS would investigate Florida's current energy trends and policies through studies, forums and workshops and present the findings to various stakeholders.

## Transportation Coordination:

Under this Market Title, funding would be used to coordinate with the Florida Department of Transportation (FDOT) on monitoring right and left turns on red to reduce idling and save energy. FDACS would monitor FDOT's continued implementation of hot-mix recycling for asphalt pavements.

Based on a review of the activities that would be funded under the above Market Titles, DOE has determined the projects that would be funded under these Market Titles will not significantly impact human health and/or the environment and they are categorically excluded from further NEPA review under CX A9 "information gathering," and CX A11 "technical advice."
