### Rational for determination:

The U.S. Department of Energy (DOE) provided \$1,091,000 of federal funding to the State of Michigan under the DOE's Annually Appropriated State Energy Program (SEP) for 2012. Michigan will match the federal funding with \$218,200 in state funds. Additionally, Michigan will carryover \$730,545 in federal appropriations and \$237,186 in state funds, for a total of \$2,276,931.

Michigan proposes to fund the following Market Titles:

Buildings-Residential, Commercial, State/Local Government and Schools:

Under this Market Title, funding would be used to promote energy efficiency and conservation by conducting building

code and building operator trainings, and employ regional technical assistants to perform energy audits, outreach and offer technical assistance. SEP FY 2012 funds would not be used for ground-breaking activities, retrofits or equipment purchase and/or installation of renewable energy projects.

### Education Outreach:

Under this Market Title, Michigan would provide educational opportunities to residents to increase knowledge of programs and resources for energy efficiency and renewable energy. This would be executed through workshops, identification of market barriers and collaboration with strategic partners to maximize the impact of funding and outreach.

#### Policy & Program Planning:

Under this Market Title, funding would be used to support the continuing operation of SEP activities performed by Michigan Energy Office (MEO) personnel. This would include management of sub-grants and contracts, progress reports, nationwide SEP meeting participation, and development of policies to enable wider adoption of energy efficiency and renewable energy measures.

### Renewable Energy-Solar, Wind & Biomass:

Under this Market Title, Michigan would help to develop renewable energy zoning and building code supplements, streamlined permitting procedures, and stakeholder education. SEP FY 2012 funds would not be used for groundbreaking activities, retrofits, equipment purchase, and/or construction or installation of renewable energy projects.

### Revolving Loan Fund-FY 2012:

Under this Market Title, SEP FY 2012 funds would be used to issue direct loans to small companies to purchase and install energy conservation measures, manufacturing equipment and retooling. The NEPA Template does not apply to FY 2012 funding. Project details and locations are unknown and this Market Title is conditioned pending additional NEPA review.

#### Technology Demonstration:

Under this Market Title, funding would be used for up to three renewable energy installations in either solar, wind or biomass. Project details and locations are unknown and this Market Title is conditioned pending additional NEPA review.

#### Transportation:

Under this Market Title, MEO would provide technical and promotional support for the three designated Clean Cities Coalitions and to the West MI Clean Cities Coalition, currently in pursuit of the designation.

#### Revolving Loan Fund-SEP ARRA:

Under this Market Title, loans would be made to private and public entities for eligible projects with SEP ARRA funding. A NEPA Template has been signed for this Market Title and any project that fall outside the bounded categories of the NEPA Template will be submitted for additional NEPA review/approval.

DOE has determined the projects that would be funded under the following market titles will not significantly impact human health and/or environment: "Buildings-Residential, Commercial, State/Local Government and School," "Education Outreach," "Policy & Program Planning," "Renewable Energy-Solar, Wind & Biomass," and "Revolving Loan Fund SEP ARRA." These market titles are categorically excluded from further NEPA review under CX A9 "information gathering," A11 "technical advice," and B5.1 "actions to conserve energy or water."

Market titles "Transportation," and "Revolving Loan Fund-FY 2012" are restricted and require further NEPA review prior to authorization of federal funds.

### NEPA PROVISION

DOE has made a conditional NEPA determination for this award, and funding for certain tasks under this award is contingent upon the final NEPA determination.
