In accordance with the Department of Energy Order 451.1B, attached is the 2013 Annual National Environmental Policy Act (NEPA) Planning Summary for the Berkeley Site Office (BSO). The attached summary provides a brief description on the status of ongoing Environmental Assessment (EA) activity at the Lawrence Berkeley National Laboratory (LBNL). Presently, there are no ongoing Environmental Impact Statements (EIS) at LBNL. In addition, no new EAs are expected in the next 12 months, and no new EIS are expected in the next 24 months.

BSO has evaluated whether a site-wide EIS would facilitate future NEPA compliance efforts. We have determined that, based on the projects that are currently funded or will be funded, a site-wide EIS is not necessary.

The ongoing EA summary and this memorandum will be made available for public review at the public reading room in City of Berkeley Main Library and the BSO NEPA website.
