

## What's New: Project Management Workshop Recap

On March 18 & 19, OECM hosted the 2008 DOE Project Management Workshop at the Fairmont Hotel in Washington, DC. The workshop theme: "Improving Contract (CM) and Project (PM) Management" was successfully integrated throughout the two days. Ms Ingrid Kolb (MA-1) introduced the agenda and noted that adding contract management information to the workshop fostered better project management practices.

Keynote speakers, a separate panel discussion, and other speakers all addressed the recent Office of Engineering and Construction Management Project Management Root Cause Analysis (RCA) and Corrective Action Plan. The Secretary of Energy and

Doe's Chief Financial Officer (both Keynote speakers) discussed the value of the RCA and expected improvements DOE will gain from this self-assessment effort. Panel discussions were presented by the PM awardees on what worked in their award winning projects.

An update and "Way-Ahead" on the Program Management Career Development Program (PMCDP) was followed by a lively panel discussion and questions from the audience. The panel, consisting of members of the Certification Review Board (CRB), led the discussion on "How can we improve?"

PMCDP will continue to focus on developing FPD com-

petencies and the need to match the FPD to the project. Curriculum reviews and course audits will help us maintain the discipline and rigor of our certification process. We must not lose sight of the over-arching goal: Well trained and experienced Federal Project Directors on all construction and EM clean-up projects.

## Root Cause Analysis Approved by Secretary Bodman

On April 7, 2008, the Contract and Project Management Root Cause Analysis (RCA) report was approved by Secretary Bodman. The approval memorandum and the RCA Report have been posted on the Department of Energy, Office of Management website at <a href="http://management.energy.gov/">http://management.energy.gov/</a>

As stated in the Secretary's

memorandum, improving the Department of Energy's project and contract management is a top Departmental priority. Excellence in this area helps ensure that the Department meets its strategic objectives, provides value and fosters public confidence in the Department's ability to manage its responsibilities. This RCA provides a foundation for identifying and implementing corrective measures that will result in significant,

measurable, and sustainable improvements in the Department's contract and project management performance and culture. A separate Corrective Action Plan (CAP) will follow this RCA and be implemented to effect the required culture change.

## **PMCDP** Update

The PMCDP module in CHRIS/ESS has been updated to reflect past competency refinements approved by the Certification Review Board (CRB). This includes the new level I core requirement for the PMCDP course "Integrating Safety into Project Management;" the addition of the PMCDP course "Environmental Laws and Regulations & National Environmental Policy Act" as a level 2 elective; moving the level 3 Group B elective course "Implementation and Management of Performance-Based Management Contracting" to Group A; up-

dating the level 4 requirement for program management experience at HQ to a minimum of 180 days of program management duties at DOE headquarters; and renumbering of the competencies accordingly. This change is effective as of April II, 2008. All persons with active profiles in the PMCDP module are affected by this software update. Your information has been automatically migrated to the new compe-

If you have completed the new level I core requirement for the PMCDP course "Integrating Safety into Project Management" or have the equivalency for this competency (are a Senior Safety Technical Manager) be sure to enter your data into the new competency #1.5.1. All currently certified FPDs are required to complete this training or the equivalent by no later than January 31, 2010. The CRB will receive reports out of CHRIS/ESS to monitor the progress towards compliance with this PMCDP requirement.

#### **PMCDP Question of the Month:**

#### Can I get CE hour credit for training taken prior to my most current certification date?

Answer: Continuing education (CE) hours must be attained after the date of your most current certification. Training taken before the certification date will be disapproved by OECM, so be sure to check the dates before you enter the request! If you are not sure of the exact certification date, check out the "PMCDP CE Hour Summary Report" found on the PMCDP drop-down menu on ESS. Your current biennial due date is at the top of the page. Your most recent certification date is two years less than this biennial due date. ### Earn a Masters in Project Management

The U.S. Department of Energy (DOE) recently established a partnership with Boston University (BU) that allows DOE employees to receive credit towards a Master of Science in Project Management. The partnership enables participants who have successfully completed previous training and/or certification requirements to waive up to two of the four required BU project management courses. A third course may be waived if participants successfully complete an exam and write a publishable research paper.

You will receive information about the curriculum, the program format, and the application process.
