## Project Management Systems and Practices in DOE

The *Project Management Systems and Practices in DOE* course focuses on the critical decision process, especially DOE O 413.3A. It also addresses the Federal budgeting process, regulations affecting DOE project managers and FPD responsibilities.

The course will be valuable to Federal Project Directors (current and prospective) as well as integrated project team members. Successful completion of the course fulfills requirements

for working level knowledge of the FPD's roles and responsibilities, familiarity level knowledge of NEPA, expert level knowledge of DOE O 413.3A and working level knowledge of budget process all required in level one of the Certification and Equivalency Guidelines (CEG).

OECM is updating to the PMCDP Certification and Equivalency Guideline to include the recent changes to DOE Order 361.1B and other Certification Review Board (CRB) competency refinements. The draft guidance will be reviewed at the 22 May

CRB meeting and then placed into the REVCOM process for program office comments. The Directives Point of Contact (DPC) for your division will receive an automatic notice when this document enters REVCOM. If you have recommenda-

tions, you should check with your DPC to see how your program office is coordinating the REVCOM response. Your participation in this update is crucial to the continued success and improvement of the PMCDP.

# Certified FPD Corner

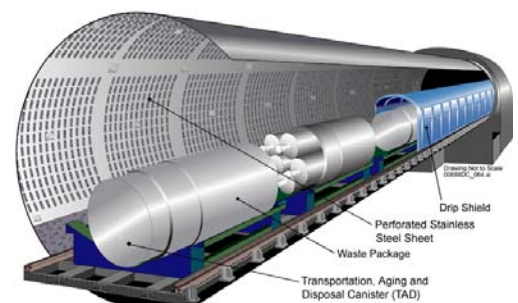
## YUCCA Mountain Repository Project FPD: Vincent Lorii

### **PMCDP Question of the Month**

**Question: If I attend a training course or seminar with subject matter relevant to the FTP Certification and PMCDP Curriculum, will OECDM forward a PMCDP course exam to my organization training coordinator to proctor so that I may get credit for having completed one of the PMCDP courses?**

Answer: No. The certification process provides for submission of life experience and education as equivalencies for demonstrating competencies required for FTD certification. The PMCDP curriculum has not been designed to “test out” of its requirements with an elaborately administered psychometric testing program. The exchange of ideas, lessons learned, knowledge management, best practices, and building networks within the DOE PM community are all benefits which would be lost by having a certification system based solely upon testing. While we endorse each DOE FPD self-directing his or her own set of project management capabilities, we must maintain a core set of standardized processes to ensure the fairness and integrity of certification and provide for, ultimately, the achievement of our project performance objectives.
