What are biobased products?

...commercial or industrial products (other than food or feed) composed wholly or in significant part of biological products including <u>renewable agricultural materials</u> (plant, animal, and marine materials) or forestry materials.





What is BioPreferred?

BioPreferred makes it easy for you to make a difference by identifying and establishing new markets for biobased products.





What is BioPreferred cont.?

- 1. Federal Procurement Preference Program
 - Federal agencies and contractors are required to purchase qualifying products
- 2. Voluntary Labeling Program
 - Will allow manufactures and vendors to use a USDA logo to identify qualifying products



Federal Acquisition Regulations

- Final Rule published November 7, 2007
 - agencies must consider biobased products in acquisition planning and solicitations;
 - new solicitation provisions and contract clauses.





USDA's Role Federal Procurement Preference Program 1. Establish Guidelines Published January 11, 2005 2. Designate BioPreferred Items (or generic groupings of biobased products that receive procurement preference)

3. Establish BioPreferred model procurement program Published January 11, 2006

Identified Biobased Products

 USDA has identified over 10,000 biobased products commercially available across 170 items (generic product categories)





BioPreferred Designated Items

- March 2005 6 items designated
 - mobile equipment hydraulic fluids
 - roof coatings
 - water tank coatings
 - diesel fuel additives
 - penetrating lubricants
 - bedding, bed linens, and towels



BioPreferred Designated Items

- 30 additional items waiting for publication of Final Rule. Examples:
 - Containers
 - Hand Cleaners and Sanitizers
 - Insulating Foams for Wall Construction
 - Greases
 - Bath and Tile Cleaners
 - Firearm Lubricants
 - Laundry Care Products

Voluntary Labeling Program

- 1. USDA logo to identify qualifying products to Federal and commercial markets.
- 2. Proposing to allow products that:
 - are required for procurement preference,
 - not currently in the preference program, and;

USDA's Implementation Strategy

- 1. Establishing the Department as a leader in biobased purchases
- 2. Providing support and guidance to other Federal agencies and to biobased manufacturers.





USDA's Implementation

Strategy

- Encouraging the use of both designated and non-designated biobased products
- Internal Goal:
 - Increase the number of USDA contracts containing biobased products by at least 50 percent by FY 2012

USDA's Implementation

Strategy cont.

- Biobased product use in Headquarters
- Identifying USDA field agencies for potential biobased product use
- Establish a BioPreferred recognition program, "BioPreferred Champions."

USDA Reporting and Tracking

- Updated the USDA Procurement Forecast System to include a biobased identifier
 - Updated the IAS procurement system to gather information on number of contracts containing biobased products
- Working on interagency working groups
