Annual NEPA Planning Summary

Attached is the Annual NEPA Planning Summary for LM. No Environmental Impact Statements (EISs) are planned or ongoing for the period of 2011 to 2012, and LM is not a cooperating agency on other agencies' Environmental Assessments (EAs) or EISs. LM is, however, planning to complete two EAs in 2011 that were begun in 2010. One EA (DOE/EA - 1747) considers impacts related to breaching five earthen dams on the Rocky Flats, CO, Site; it is expected to be completed in April 2011. A second EA (DOE/EA - 1770) considers impacts related to leasing a portion of the Durango, CO, Disposal Site for construction, operation, and maintenance of a photovoltaic solar energy system. The EA is expected to be completed in February 2011.

No other EAs are expected to be prepared during the next 12 months. The prior, programmatic EA for the LM Uranium Lease Program is under litigation. Future NEPA evaluations for actions under this program may be forthcoming; however the number of documents and the schedule cannot be determined at this time.

The Office of Legacy Management has not received any funding under the American Recovery and Reinvestment Act.
