- 4 Major OSDBU Program Areas
 - Verification Program
 - Acquisition Support
 - Direct Access
 - Outreach

Verification Program

- Creating a Veteran-centric, Veteran-friendly Verification process
 - Simplified Registration
 - Direct contact established for questions and assistance.
 - Only upload pre-qualification documents
 - Pre-qualification Assessment by evaluator to identify “no-go” issues, “Red Flags” needing explanation
 - Opportunity to correct “no-go” issues based on Veteran schedule
 - Upload complete application only after clearing no-go issues.
 - Pre-Determination Findings briefed to Vet if any ineligibility issues
 - Federal Review

- **Market Research**
- **VA Business Intelligence Tool (BIT):** a web-based market place that connects businesses with capabilities to procurement officials, program managers, and contracting officers in VA, in other federal agencies, and in the commercial sector, who have procurement opportunities relevant to VOSB and SDVOSB
