1. Nuclear Waste Partnership, LLC: EVMS certification pending review in FY2017.
2. Savannah River Nuclear Solutions: EVMS certification has been suspended, re-certification review ongoing.
3. Idaho Treatment Group: EVMS certification review is in progress; outcome is pending resolution of corrective actions.
4. Per the Contract Mod, EVMS is required and needs to be certified by a third party. Via an EVMS review, EM-53 noted that compliance was verified based on contract requirements to use a tailored system.
5. Fluor B&W Portsmouth LLC (FBP): 1Q FY2016 DOE EM Compliance Review found FBP to be non-compliant with several of the EIA-748 guidelines pertaining to EVMS. FBP is responding to report.
6. Los Alamos National Security, LLC: EVM certification revoked Nov. 6, 2014. The Office of Project Management Oversight and Assessment (PM) is currently reviewing the contractor and will update status if necessary.
7. CH2M Hill-B&W West Valley: EVMS certification review is in progress; outcome is pending resolution of corrective actions.
